

Changes to "Deming Prize Examination", "TQM Diagnosis by the Deming Prize Committee", "Post Prize review three years after winning the Deming Prize", and "Pre-application consultation"

(Effective from 2023)

The Deming Prize Committee

Under the continued pandemic situation caused by the COVID-19 since 2020, the Deming Prize Committee was held on January 24, 2023, where implementation and operations of the 2023 Deming Prize Examination, TQM Diagnosis by the Deming Prize Committee, Post Prize review three years after winning the Deming Prize and Preapplication consultation were deliberately discussed.

It was concluded at the committee meeting that the following policies were approved:

1. Deming Prize Examination Policy

- —The examination, in principle, will be conducted on-site. In case conducting the examination on-site would not be feasible due to the COVID-19 status or other reasons, then it will be conducted remotely through online mode.
- —The committee will also accept both the examination and diagnosis to be conducted online for the same organization.
- —In accordance with the Deming Prize Committee rules, priority will be given to domestic organizations for both the examination and diagnosis.
